Another project is the patient-led round table. This is a public-private partnership developed to bring real world data and patient experiences together with a broad array of experts to conduct studies aimed at improving outcomes for implant patients worldwide. The Association is working with stakeholders on implementing the recommendations from the National Academy of Medicine Study.
